**1. Online ACH Customer Bill Pay (Free Service)**

- a. Customers with existing Patron Access Account – Please contact our office at the number listed below and request an ACH Authorization form.
- b. Customers who do not have a Patron Access Account – Please register for Patron Access account on our website [www.skylandgrain.com](http://www.skylandgrain.com). Once your account is set up you will be notified.
- c. Call Johnson Main Office (**620-492-6210**) or Cunningham Administration Office (**620-318-6050**) to request an ACH Authorization Form or you may pick one up at either location listed below.
- d. Fill out the ACH Authorization Form with your bank account information and **ATTACH A VOIDED CHECK**.
- e. Please mail to PO Box 280, Johnson, KS 67855 or bring your ACH Authorization form with voided check to:
  - Johnson Main Office (Point of Contact: Cindy Williamson or Paige German)
  - Cunningham Administration Office (Point of Contact: Aaron Murphy)
  - For your **SECURITY** please **DO NOT** email your Bank Information.
- f. You may also fax ACH Authorization form with voided check to **620-492-0001**.
- g. Once you are notified that your Patron Access Account is set up for ACH Online Bill Pay, an  icon will appear in your account. You are now setup and ready to go.
